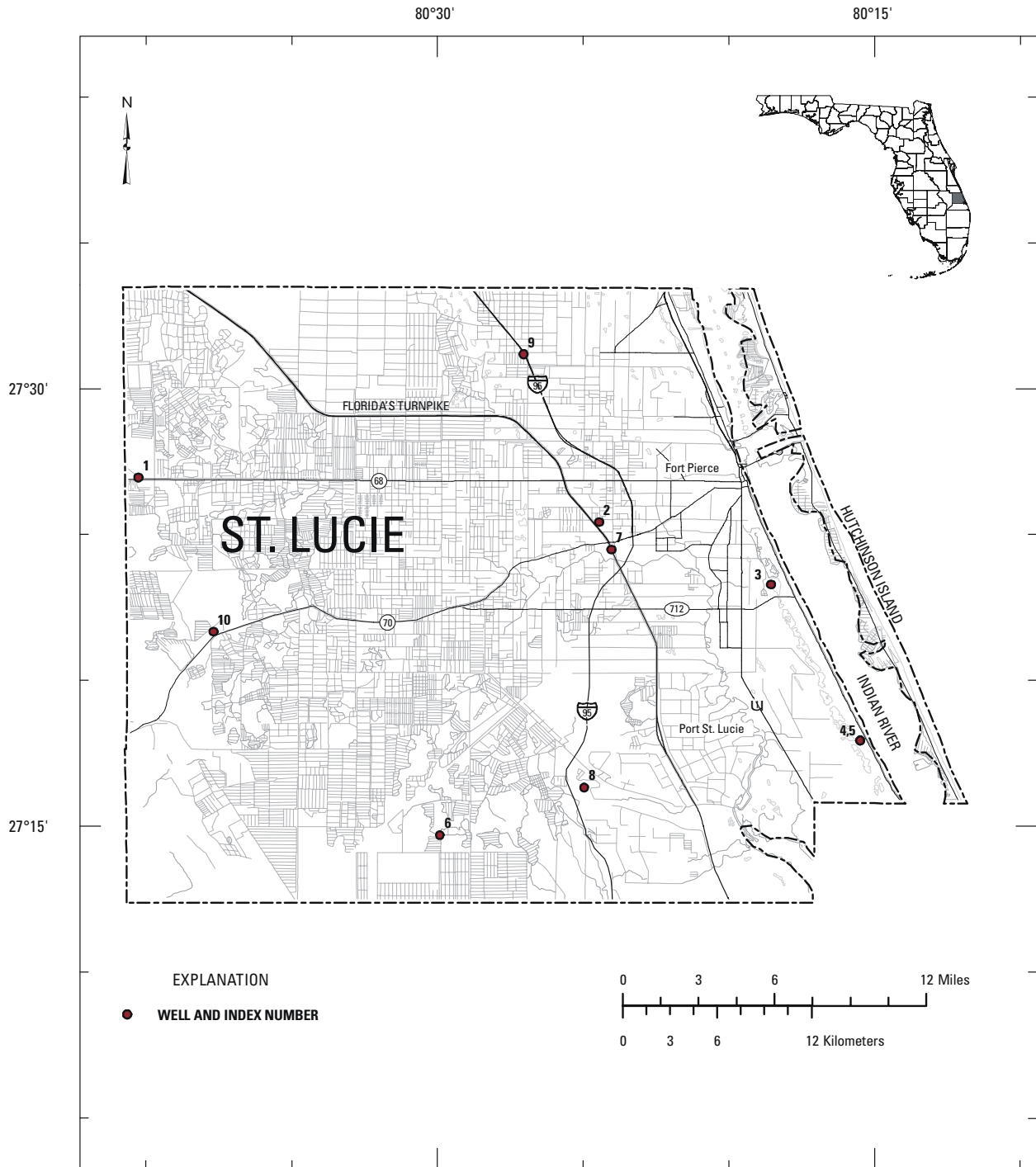


Figure 21. Location of wells in St. Lucie County
